# MEMBERSHIP AGREEMENT

The following policies shall govern all members of the Harbourtowne Country Club and are agreed to and accepted by the undersigned member.

Conduct that is likely to endanger the welfare, interest or harmony of the Club; willful or repeated infractions of house rules or of Harbourtowne policies (including failure to pay all dues, fees, fines or other indebtedness); and acts or conduct deemed disorderly, injurious or hostile to the interests or the objects or other members of the Club; all shall be cause for suspension or revocation of membership, whether such acts, infractions or conduct are performed by the undersigned applicant, anyone included in the applicant's membership, or any of the applicant's guests.

Should any member, guest of a member, or person included in the member's membership, so conduct himself or herself so as to give rise to cause for suspension or revocation of the membership, written notice outlining the charges shall be sent to the member. Member shall then have ten (10) days in which to appear before Management to defend himself or herself against such charges. After said hearing, or in the event the member fails to appear, Management, at it's discretion may: revoke or suspend membership; drop the charges; require reparation to be made by the member; or take any other disciplinary action it deems necessary. Should the member fail to make reparation or fail to perform whatever actions are required of him or her within the time period requested by management, the member's membership may be immediately revoked or suspended upon the expiration of said time period, in which case Management will notify the member of such revocation or suspension.

Should revocation or resignation of membership take place, the membership dues and initiation fees are not refundable.

Renewal of all annual memberships will be reviewed by Management and all renewals will be up to the discretion of the Management.
